Our mission is to produce and promote path-breaking scholarship, teaching, and public programs on the interaction of law and religion around the world.

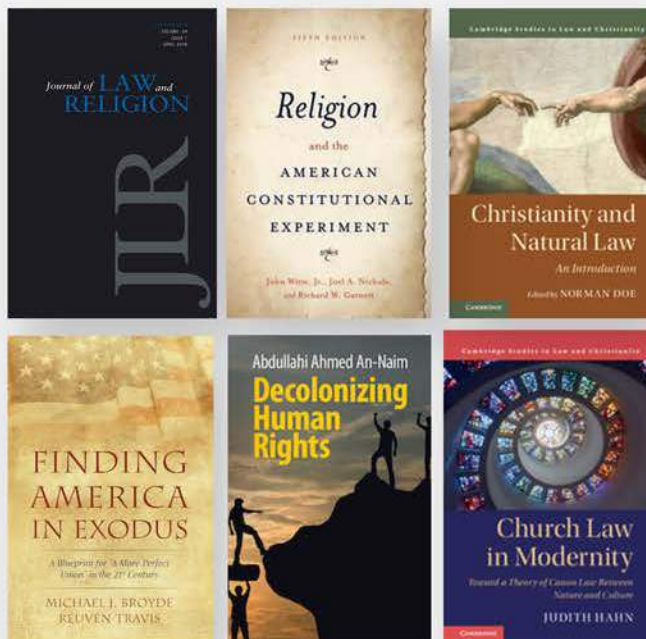
Research & Publications

Since 1982, CSLR publications in multiple languages have been the Center's most visible and enduring contribution to the global conversation about law and religion. CSLR now edits five book series with Aranzadi, Brill, Cambridge, Wm. B. Eerdmans, and Routledge.

Public Programs

Teaching & Training

Emory offers a variety of degree programs for students interested in the close study of law and religion.

Juris Doctor (JD) candidates may concentrate in law and religion, and Emory provides extensive resources for students interested in the practice track or the academic track.

Emory also boasts **three joint degree programs** in collaboration with the Candler School of Theology and Laney School of Graduate Studies. These students simultaneously pursue a JD in combination with a Master of Theology, Master of Divinity, or a Doctor of Philosophy.

Two advanced-law programs, (SJD and LLM), are open to law school graduates, and a master-level program (JM) is open to college graduates. There is no formal concentration in law and religion available to LLM and JM candidates, although candidates within those programs may enroll in law and religion courses and seek out research opportunities with relevant faculty within their areas of interest.
